BGO targets £100m UK student platform with new partner post-recap

Portfolio seeded with two assets recapitalised by private equity firm's secondaries business

BentallGreenOak's secondaries business is building a £100m+ student portfolio, alongside a new investment partner, after securing two seed assets, *Green Street News* can reveal.

BGO Strategic Capital Partners – the private equity firm's platform, which tends to focus on secondaries and co-investment opportunities – has seeded its embryonic UK student portfolio with two assets, which have been recapitalised in joint venture with Orka Investments.

The pair have recapped two purpose-built student accommodation (PBSA) assets in Manchester and Derby. The properties comprise a total 568 beds and are well positioned to benefit from sustained rental growth and operational enhancements, BGO SCP said.

Oka and BGO SCP plan to build a £100m-plus student portfolio, after noting that the market benefits from international student demand and supply constraints.

BGO Strategic Capital Partners has a history of partnering with small and midcap managers, providing innovative capital solutions to execute business plans, recapitalise assets and grow portfolios.

Cherine Aboulzelof, managing director and head of BGO Strategic Capital Partners, said: "The UK student housing sector remains one of the most compelling living strategies in Europe, supported by strong fundamentals and deep institutional demand. Orka is a technology-driven investment advisory firm, founded by Raoul Malhotra and Oskar Sköldberg in 2020, which uses a club investment model to give investors direct access to real estate opportunities. It sources and manages investments on behalf of global investors and also works in partnerships.


